

Illinois Integrys, Peoples Gas and North Shore Gas Employees' Matching Gifts Program

The Program

Each year, employees generously give of their time and talents. The Matching Gifts Program is designed to further encourage employees to support nonprofit organizations with personal financial donations.

The company will match \$1 for \$1 of eligible donations up to a combined total of \$2,500 each fiscal year per employee. The minimum donation that will be matched is \$50.

The gift may be in the form of cash, a check, credit card or stock in a publicly traded company. Gifts in securities are matched in dollars at their appropriate valuation for tax purposes.

Who Is Eligible to Participate?

The Matching Gifts Program is open to Integrys Energy Group, Integrys Energy Services, Integrys Gas Group, Integrys Business Support, Peoples Gas and North Shore Gas employees in Illinois.

Eligible Gifts

Donations to organizations in the categories below may be eligible for matching funds. Organizations must operate in areas where Integrys, Peoples Gas and North Shore Gas employees in Illinois work, with the exception of colleges and universities, or live. They must be tax-exempt under Section 501(c)3 of the Internal Revenue Code.

Eligible categories:

- Arts and culture
- Community and neighborhood development
- Human services and health
- Environment
- Schools (grades K-12)
- Colleges and universities*

*Colleges and universities in the United States are eligible in this program.

Ineligible Contributions

We limit Matching Gifts to the eligible categories listed. We do not match gifts to these types or organizations:

- United Way and other combined appeals
- Civic groups, including fraternal, social, union or veterans organizations
- Religious or political organizations
- Organizations whose philosophy and mission conflict with company positions
- Private foundations
- Gifts to individuals
- In-kind gifts
- Pooled contributions by more than one individual

To Participate

To request a matching gift, employees should complete Section A on the reverse side of this sheet and mail it, along with their gift, to the eligible organization.

The deadline for submitting Matching Gifts requests is December 1 of each year.

For walks, runs and bike-a-thons, only the employee's own donation will be matched. A copy of the employee pledge sheet must be attached to this form and returned by the beneficiary organization with verification of the employee's contribution.

An authorized official of the nonprofit organization should complete Section B and return the form to the Matching Gifts Program coordinator. After receiving the completed form, the program coordinator will verify the eligibility of the organization and the gift.

The company reserves the right to amend, suspend or terminate its Matching Gifts Program at any time without prior notice.
