Rider PRG Producer of Renewable Gas Transportation Service

Section A - Applicability and Purpose

Service under this rate is available to Producer of Renewable Gas ("Producer") as those terms are defined herein that deliver Renewable Gas into the Company's distribution system for use and consumption by the Company's gas transportation customer(s) located in the Company's service territory. The Producer must contract with a supplier using Rider P - Pooling Service or Rider AGG - Aggregation Service, delivering gas to the Company for transportation with such gas to be sold to a Transportation Customer receiving service and subscribing under Rider FST, Rider SST or Rider CFY on the Company's distribution system.

The Producer and the Company shall enter into a mutually agreeable written Contract to define the specific terms of service under this rate schedule.

The Company, in its sole discretion, may reject a Producer taking service under this Rider PRG related to Company concerns regarding, but not limited to: (1) feedstock used for the Renewable Gas, (2) location of the Producer's interconnection on the Company's distribution system, (3) volumes proposed by Producer for Renewable Gas deliveries at the interconnection and (4) other issues that may affect the deliverability and quality of the Renewable Gas on the Company's distribution system.

The Producer shall be responsible for ensuring the Renewable Gas consistently meets all Company gas quality standards, as specified in the Contract, at the Delivery Point on the Company's distribution system.

Service under this rate schedule is available on a best efforts basis, and the quantity of Renewable Gas the Company will accept from the Producer each day may be limited, and is dependent on (a) the Company's ability to physically accept deliveries at the Delivery Point each day; (b) the ability of the Transportation Customer(s) purchasing the gas to consume the total quantities produced; and (c) the Renewable Gas meeting all applicable gas quality standards.

Eligible Producers electing service under this rate schedule shall pay for all equipment necessary to effectuate deliveries at the point of interconnection, including, but not limited to, valves, separators, meters and telemetric equipment, quality measurement, odorization equipment and other equipment necessary to regulate and deliver gas at the interconnection point. Prior to commencement of service, the Producer must have Company- installed telemetric equipment in place to monitor daily injections. The Producer shall for all pay for reasonable changes, if any, required to add the Producer's new interconnection point. Such payments shall be considered nonrefundable contributions. The Producer shall also be responsible for the ongoing operations and maintenance activities associated with the interconnection for the duration of the Producer's Contract subject to this Rider PRG.

All equipment installed shall remain the sole property of the Company unless otherwise negotiated in the Contract.

Section B - Definitions

As used in this rider, the terms below are defined as follows:

Contract means an agreement between the Producer and the Company defining the specific terms of service and charges under this rate.

Producer means a person, entity or its agent that makes or processes Renewable Gas.

Transportation Customer means a customer receiving service and subscribing under Rider FST - Full Standby Transportation Service, Rider SST - Subscription Storage Transportation Service or Rider CFY - Choices For You Transportation Service on the Company's distribution system.

Renewable Gas (RNG), also known as biomethane or cleaned biogas, means gas produced from agricultural, live animal manure, industrial grade food waste, wastewater treatment sludge, or municipal waste that, with or without further processing, has characteristics (a) consistent with the provisions of all Company gas standards including its renewable gas standards as may be updated from time to time, and (b) that in the Company's sole belief and discretion does not otherwise pose a hazard to inclusion in the Company's distribution lines when co-mingled with non-RNG natural gas.

Section C - Character of Service

The Delivery Point shall be the mutually agreed upon point of interconnection of the Producer's facilities into the Company's distribution system. Renewable Gas delivered to the Company under this rate schedule shall be included in the daily nominations of the Pool as defined in Rider P.

The Producer shall deliver, and the gas Transportation Customer(s) shall receive and consume, such Renewable Gas within the service territory of the Company.

During a Critical Day or Operational Flow Order, the Company will have the right to restrict the availability of deliveries and receipts made under this rate schedule. In the event a restriction occurs, a Company representative will notify the Producer at such time.

* Section D – Charges

The charges for service hereunder shall be the charges contained in the Contract between the customer and the Company. Charges shall include: the capital cost to the Company of all natural gas interconnection requirements with the Producer including but not limited to measurement, controls, main, buildings, security along with periodic operations and maintenance activities and all other costs incurred by the Company relating to the interconnection and associated RNG. Unless the Contract provides for payment on a more expedited basis, charges related to capital costs related to the natural gas interconnection shall be recovered ratably over a period not to exceed 20 years. Operation and maintenance activities shall be recovered on a periodic basis.

The Producer shall provide a financial instrument or otherwise a surety satisfactory to the Company in an amount equal to or more than the amount of outstanding capital costs for the interconnection.

Section D - Charges (cont'd)

All balancing and cash-out provisions will be applied to the receiving Transportation Customer(s) in accordance with the approved tariffs under which they take Transportation service.

The Company shall charge the Producer periodically over the term of the Agreement for the recovery of the capital and operating and maintenance costs as indicated in the Agreement.

Section E - Creditworthiness

The Company, on a non-discriminatory basis and at its reasonable discretion, may require the Producer to provide adequate assurances of payment, in the form of a corporate or parent guaranty or irrevocable standby letter of credit, in form and substance reasonably acceptable to the Company, or a cash deposit, to assure payment of the Company's cost of interconnection.

Section F - General Terms and Conditions

Except as provided herein and in the Contract under this rate schedule, all other provisions of the Company's Gas Transportation Tariff governing the transportation of natural gas shall apply.

Section G - Commission Review

The Company shall file all Contracts for service under this rate schedule with the Illinois Commerce Commission. These Contracts shall be filed confidentially and shall be for review purposes only, no action or approval shall be required by the Commission. Commission gas quality and safety standards apply to all Company and Producer activity pursuant to this Rider PRG.
